Above listed politicians & civil servants support the King in starting – expanding – maintaining the Dictatorship the Netherlands.

Above listed persons support the ICC-killings by ICC-personnel; they ignore evidence of these victims.

In accordance with the UN-charter – Torture treaty – Human right treaties – Constitution Netherlands, the above listed persons are legally obliged:

1. To stop the Dictatorship the Netherlands and recognize me as InterimPrimeMinister for NL.
2. To protect the people against crime & terrorism. Based upon the true legal facts about the NL parliament & bureaucracy.

My demands:

I demand for all persons above listed and against whom I started the ICC-lawcase today:

1. **A prison-sentence of one year in the International Criminal Court prison.**
2. **A payment of 100 euro per person per month from 1may2007 on untill the day they are being put in prison.**

These warcriminals can offer me a Settlement & Payment for the damage, after reading this letter.

1. **They must explain to me in writing and to the people publicly which legal mistakes they have made in connection with DesireeStokkel – Monarchy – NL – ICC - EU in Holland and internationally.**
2. **They must offer me a Payment for Damage of a hundred euro per month per person from 1may2007 on, counting until the day they write me the letter with which they prove that they regret their criminal methods of work. This will keep them out of ICC-prison, but will label them as warcriminals who have bought themselves free.**
