ICC,

I hereby start an International Criminal Court lawcase against:

1. The Healthcare Inspector NL, mrs Ronnie van Diemen
2. Mrs. Drs. M.V.Kloosterman.

I have received a letter from the Ministry of Health, the Healthcare inspector from 23june2017.
See supplement.

In this letter they do confirm the receipt of my emails inherent to the International Criminal Lawcase against NL.

They also prove that the Healthcare Inspector and other personnel working for the Ministry of Health, want to support the Members of Parliament, the Members of the Royal family and other Rulers in NL with torture – murder on the body of Dutch Civilians.
Plus the body of victims who start lawcases inside ICC, plus Civilians in warzone and Victims of terrorism, all over the World.

Above listed persons support the ICC-killings by ICC-personnel; they ignore evidence of these victims.

In accordance with the UN-charter – Torture treaty – Human right treaties – Constitution Netherlands, the above listed persons are legally obliged:

1. To stop the Dictatorship the Netherlands and recognize me as InterimPrimeMinister for NL.
2. To make the International Criminal Court operate like a fair court of law.
3. To make the United Nations and European Union stop Dictatorshop NL and ICC-killings. And to signature Healthcare contracts in State of Law the Netherlands for all persons who depend on Sound governance on behalf of the Healthcare Ministry and its inspectors / personnel in the Netherlands.
4. To clean up the Ministry of Health and make all persons working for this Ministry – Parliament – or working in Organisations in the Healthcare-sector – operate legally correct.

My demands:

I demand for all persons above listed and against whom I started the ICC-lawcase today:

1. **A prison-sentence of one year in the International Criminal Court prison.**
2. **A payment of 100 euro per person per month from 1may2007 on.**

These warcriminals can offer me a Settlement & Payment for the damage, after reading this letter.

1. **They must explain to me in writing and to the people publicly which legal mistakes they have made in connection with DesireeStokkel – NL – ICC – EU – UN and Healthcare, internationally.**
2. **They must offer me a Payment for Damage of a hundred euro per month per person from 1may2007 on, counting until the day they write me the letter with which they prove that they regret their criminal methods of work. This will keep them out of ICC-prison, but will label them as warcriminals who have bought themselves free.**
