He refuses to live and work by the Constitution Kingdom the Netherlands.  
The UN Charter – Torture treaty – Human right treaties.  
The Constitution Republic NL.

1. He refuses to respond legally correct to the ICC-lawcase against NL.  
To implement & conduct my letters for legally correct solutions against crime / terrorism.
2. He ignores all his legal obligations when he is legally obliged to remove criminals from the Parliament – Monarchy – Lobby, based upon my evidence.
3. He keeps 2 criminal Police-officers in their labourcontract.  
This Neighbourhood Police – officer and Detective have mentally tortured my on command of the Cityhall Bloemendaal–NH, for publishing my file on a website. 4. He misuses my position InterimPrimeMinister online; he is a parasite on my body for the production of his cover 'Head of Police'.
  - a) He knows that criminals / terrorists observe me and work with my evidence against NL – EU – UN.
  - b) He ignores that fact that crime / terrorism increases due to his behavior Even when I have Human traffic-criminals or Maffia at my frontdoor, Akerboom ignores this fact.
5. He supports the warcrimes conducted by Commandors of the Ministry of Defence, against whom I started an ICC lawcase.
6. He supports the criminal methods of work of the Ministry of Common Affairs; I have started an ICC-lawcase against civil servants working for the Min of CommonAffairs.
7. He supports criminal Judges – Prosecutors – Lawyers against whom I started an ICC-lawcase.

They misuse my ICC-evidence as a murder-tool in their hands and they support the Dutch perpetrators of the MH17 flightcrash.

This results in the legal fact that the full MH17 investigation is 100% worthless in courtroom.

The only possibility left to put the real perpetrators – guilty of shooting down the MH17 plane – in Prison, is to clean up the MH17 investigation first.

The MH17 family-members have had 3 years time to clean up the NL-parliament, the Monarchy, the Dutch Safety Board, the EU – UN.

3. All persons against whom I start an ICC-lawcase must be removed from their labourcontract – now they are **ALL** official warcriminals – and must be replaced with new persons who do live & work with the UN charter – Torture treaty – Humanrighttreaties – Statute of Rome legally correct. And the Constitution Republic NL
4. Over the past 10 years, I have kept my demands 'fair'. I only demand 'one year in prison' for a person who in fact, must be jailed for live for warcrimes taken the gravity of their crimes.  
Previously, I demanded a 100 euro payment per person per month for the damage they cause me, starting from the day they entered my life. This system changes in the letter of 10july2017, with which I start an ICC-lawcase against all Presidents – Ministers of Foreign affairs and more....., because they all misuse me as their Slave for reasons of personal wealth and the realisation of crime – terrorism – war in their advantage.

**One year prison-sentence + payment for damage.**

**The payment for the damage, persons against whom I start an ICC-lawcase,  
is being RESETTED in the Cleanup letter of 10july2017:**

**I demand that all persons, against whom I start an ICC-lawcase pay me a  
100 euro per person per month – counting from 1may2007 on, as a  
payment for the damage they cause me. They have misused my patients  
and civilized behavior towards them; they turned themselves into better  
criminals in stead of better persons who operate legally correct.**

5. **I demand that all Politicians – Embassadors / Presidents / Ministers of  
Foreign affairs each may me one million euro for the damage they cause me.**

I demand of every person – other than Embasador – President of a nation – Minister of Foreign affairs of a nation – a payment of a 100 euro per person per month, to be calculated from 1may2007 untill the day they write my this settlement-letter. They will be internationally recognized 'as warcriminals who get off extremely light & easy', but they won't go to prison.

7. I demand of the Ministry of Common Affairs a settlement & payment for five million euro, after TAX. Now I am InterimPrimeMinister I can arrange this Myself, but for Peace & Justice on Earth, 'I'd rather see that Dictators Markrutte and King Willem-Alexander, explane to the people 'what has gone wrong and that NL is a Republic from 18nov2016 on'.

I have chosen this amount of money to make something clear in NL.

In NL, criminal politicians have offered and payed criminals up to 4.7 million guildens for information on crime. They are kept out of prison. These criminals have turned themselves into 'better criminals' thanks to these type of payments.

**I can't put all members of the NL- ICC- EU – UN Elite terrorist group in ICC-prison; some must be left out to clean up this war- makery in Holland.**

#### Convention against torture and other cruel inhuman or degrading treatment or punishment

##### **Article 1**

1. For the purposes of this Convention, the term "torture" means any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted on a person for such purposes as obtaining from him or a third person information or a confession, punishing him for an act he or a third person has committed or is suspected of having committed, or intimidating or coercing him or a third person, or for any reason based on discrimination of any kind, when such pain or suffering is inflicted by or at the instigation of or with the consent or acquiescence of a public official or other person acting in an official capacity. It does not include pain or suffering arising only from, inherent in or incidental to lawful sanctions.

2. This article is without prejudice to any international instrument or national legislation which does or may contain provisions of wider application.

##### **Article 2**

1. Each State Party shall take effective legislative, administrative, judicial or other measures to prevent acts of torture in any territory under its jurisdiction.

2. No exceptional circumstances whatsoever, whether a state of war or a threat of war, internal political instability or any other public emergency, may be invoked as a justification of torture.

3. An order from a superior officer or a public authority may not be invoked as a justification of torture.
