**Above listed persons ignore their legal obligations anchored in the UN-charter –  
Torture treaty – Humanright treaties – Womens' right treaty.**

## **Above listed persons misuse my ICC-lawcase against the Netherlands**

1. To keep the Netherlands a Half-Dictatorship / Half- Republic NL.
  - a) They refuse to communicate based upon the legal reality about the State of Law the Netherlands, publicly.  
Behind closed doors & camera, the fact that Holland is a Dictatorship is made clear with manipulations, on behalf of the Kremlin.  
President Putin & Co keep NL alive as Dictatorship and also 'respect the work of InterimPrimeMinister DesireeStokkel', by manipulations.  
**This behavioral-pattern is a warcrime.**

### **Putin & Co relate to Holland with Torture during following communcations:**

1. The NL Dictator-parliament of President Markrutte & Co  
The Kremlin refuses to give a public statement on the legal position of the Netherlands on Planet Earth.
2. DesireeStokkel, InterimPrimeMinister  
The Kremlin refuses to recognize me officially and publicly, while they do use my ICC-lawcase – my Constitution Republic NL – my advises for their criminal manipulations they call 'Politics'.

### **NL – Iraq- Syria – MiddleEast war relationships**

The Kremlin refuses to give me acces to Peace-talks in the Middle-East, which is a warcrime. It proves that the Kremlin wants Planet Earth & criminal Politics to stay alive for the maintenance of war on Earth... and for starting more wars.

Dictatorship Holland is not any better than Dictatorship Russia, but Holland has become a Republic with a new Constitution Republic NL on 18nov2016... and Russia is legally obliged to recognize this Legel framwork publicly.

I don't know 'Why Russia doesn't want me to stop the Syria- MiddleEast war'; it must have something to do with the fact that men can not talk about Rock-Law-Love without becoming sexual'.

3. MH17 – Ukraine – ICC  
The Kremlin plays the victim-role in this file.  
Despite the fact that I - InterimPrimeMinister DesireeStokkel – have always said:'The Kremlin did not ship rockets to Ukraine with the command to remove passengers-planes from Earth'.  
I have always neutralized the criminal accusations of NL- EU – UN in connection with the MH17, so Russia should have related to me in a more intelligent and civilized **legally correct** way.
4. The small part of Business-deals which are still in proces despite the EU-sanctions against Russia  
Russia keeps the EU-sanctions alive with Torture, while I – InterrimPrimeMinister DesireeStokkel – have lifted that NL- RU- sanctions.  
What makes me furious is the fact that the Kremlin not only demolishes NL-business relations 'which can run smoothly when all parties involved operate legally correct', but also keeps it own Russian civilians poor.  
For the Fun of Torture.
5. NL- ICC- EU – UN relationships
  - a) The Kremlin keeps the InternationalCriminalCourt open as a cover for the RU-warcrimes.

Russia is not a statemember of ICC.... And has made the decision 'not to be fully coöperative with the ICC-demands anymore'. But, Russia keeps the criminal ICC-personnel in their labourcontracts and gives Russian students the opportunity to participate in Competitions for Law, inside the ICC-building.

b) Russia keeps the United Nations a 100% warcriminal-club.

In 2008, when I proved that former UN Bankimoon wants ICC to be a murderweapon for his private corruption & murders, the Kremlin refused to remove this criminal UNSG from his labourcontract... and started to manipulate / blackmail UN-desicion-making-processes. Again, Politics by Torture.
