

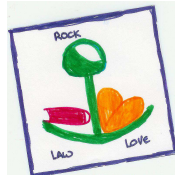

**I hereby start an ICC-lawcase against the Boardmembers and staff of Mensenrechtencollege,
CPB, CBS, VNONCW, SER, MKB.**

All listed organisations and staff refuse to conduct the NL-Constitution, Humanright-treaties and are assisting the Dutch Cabinet, Parliament, Monarchy, Lobbyists and ICC with torturing & killing civilians via my body, via my ICC-lawcase against NL.

- These organisations and staff have built the ICC-lobby via Thehagueglobaljusticeinstitute – thehaguesecuritydelta for impunity for NL-dictators inside the International Criminal Court.

According to the Torture-treaty these organisations and staff had the legal obligation during the past 8 years to help me to make former Prime Minister J.P.Balkenende & his Cabinet – Parliament – Monarchy ... and current PM MarkRutte & his Cabinet-Parliament-Monarchy conduct the Constitution for the Netherlands and Humanright-treaties legally correct...

- These organisations and staff have the legal obligation to make sure that every single Dutch national and foreigner in NL can use fundamental Constitutional and Human rights in the bureaucracy of the NL-government = complaint- commissions at the Cityhall, National Ombudsman, Lawyers, Barassociation, Legal aid Council, Judiciary Council, Courts of Law, Government organisations, Tradeunions, Political parties and lobbyist, CPB, CBS, VNONCW, MKB, SER.
- These organisations and staff have organized warcrimes in NL by ignoring all their legal obligations for me and the People.
- They have found a method to torture & kill me with... now I confront them with personal dictator-behavior. They simply ignore the Constitution and HR-treaties as a group, what makes this group dictators just as strong and powerful als Hitler, SaddamHoussein, Khadaffi, Bashiri n Sudan, Assad in Syria...etc...
- They have also caused the MH17-flightcrash above Ukraine on 17july2014 with all their lies about corruption between Cabinet, Parliament, Monarchy, Judiciary system, Compagnies, Trade unions, Employees... and Foreign governments.

- They have taken my ICC-lawcase against NL and started to build organisations and systems only good for their personal labourcontract for a life in Dictatorship NL.
They are the onces who built the Hitler-like bureaucracy and lied to the people about it.
This is a warcrime, now I and the people are excluded for Constitutional and Humanrights...
- The MH17-persons will be confronted with these violent organisations and staff during the ICC-Ukraine investigation, because the Kremlin and Whitehouse are part of my ICC-lawcase against NL.
Thus, the lobby of these organisations and staff for falsification of the MH17-report by the Dutch Safety Board is not going to take place. Truth will come to the surface, especially now ICC hides the NL-lawcase for the people on her website, but does announce the Ukraine-investigation.
People in warzone understand that both ICC and NL-dictators enjoy to torment warvictims via social media, now people can see for themselves that ICC has sent me criminal written letters in connection with the ICC-lawcase against NL I started.
- The ICC -NL-Dictatorclub now sufficates in its own lies and manipulations.
These organisations and staff feel extremely powerful now ICC has assisted them to realise impunity for themselves, which is a warcrime on behalf of ICC, UN, EU.
