InterimPrimeMinister for Holland – Désirée Elisabeth Stokkel – takes charge over MH17-investigation for reasons of national security.

UN Secretary Antonio Guterres, Dictator Mark Rutte, Embassadors,**

MH17-people, UNSG Antonio Guterres, Dictator Mark Rutte, President Petro Poroshenko, President Dato' Sri Mohd Najib,

For reasons of national security I take over the MH17-investigation from Dictator Mark Rutte in the Netherlands.

This letter runs via UNSG Antonio Guterres. I claim the labour contract Interim Prime Minister for Holland, per 18 nov 2016 – and I have put into power by decree the Constitution Republic NL –. You are all informed about this regime-change by email.

The courtfile of the International Criminal Court – lawcase I started against the Netherlands on 1 may 2007, is published on my website <http://www.desireestokkel-nl.net/>. This courtfile is also available with the UNSG Antonio Guterres office – Embassy Portugal The Hague –. And with Dictator Mark Rutte at the Ministry of Common Affairs The Hague.

The lies and manipulations by the ICC-personnel – UN Bankimoon – EU politicians – Dictator Mark Rutte – King Willem-Alexander have caused the MH17-plane to fly over warzone Ukraine and to be shot down.

Building a courtcase for MH17-flight passengers who died on 17 July 2014, above Ukraine.

I hereby determine from my judicial position the order of rank for guilty parties, to be put on trial for causing the MH17-plane to fly over Ukraine and to be shot down:

1. The ICC-president Judge Silvia Fernández de Gurmendi.
 - She took office at ICC on 20january2010.
 - She refuses to implement & conduct the UN Charter – Torture treaty – Humanright treaties – Statute of Rome – Constitution Kingdom the Netherlands.
 - She ignores all my letters of complaint about the criminal methods of work of ICC-personnel.
 - She refuses to inform the Dutch people on the security-risk they are forced to residence in, since 1may2007; the Dutch nationals can not defend themselves against the dictatorship the Netherlands and are unaware of the legal procdures they must start in order to claim 'national security for their human body'.
2. The ICC- prosecutor Fatou Bensouda.
 - She took office at ICC on 15june2012.
 - She refuses to implement & conduct the UN Charter – Torture treaty – Humanright treaties – Statute of Rome – Constitution Kingdom the Netherlands.
 - She ignores all my letters of complaint about the criminal methods of work of ICC-personnel.
 - She refuses to inform the Dutch people on the security-risk they are forced to residence in, since 1may2007; the Dutch nationals can not defend themselves against the dictatorship the Netherlands and are unaware of the legal procdures they must start in order to claim 'national security for their human body'.
3. Former UNSG Bankimoon. He refused to stop the warcrimes exercized by ICC-personnel and he supports the Dictatorship the Netherlands.
4. King Willem-Alexander of the Netherlands.
 - I started an ICC-lawcase against him on 2june2014, for the fact that he signatures all Dutch laws & treaties produced by a 100% dictator parliament in the Netherlands. His family is in charge of the Dutch Safety Board, a criminal party in my ICC-lawcase against NL from 1may2007 on.
 - He refuses to implement & conduct the UN Charter – Torture treaty – Humanright treaties – Statute of Rome – Constitution Kingdom the Netherlands.
 - He ignored all my letters of complaint about the criminal methods of work of the NL-parliament, NL lobby and ICC-personnel.
5. Former KLM CEO Camiel Eurlings.
 - A Member of the political party CDA. I started an ICC-lawcase against NL in may2007, due to the fact that former Prime Minister for Holland and CDA member JanPeterBalkenende refused to guarantee me 'access to a court of law in the Netherlands – and tried to murder me for fun-'.
 - A Member of Thehaguesecuritydelta, where ICC and compagnies lobby at TheHagueGlobaljusticeinstitute, to make sure that leaders in Holland can be dictators above the law and free as a bird.
6. All Members of the Dutch parliament in their labourcontract on 17june2014, the day of the MH17-crash.
7. The EU-personnel, but they can not be put in trial for the MH17 now the United

Nations is the institute that has constructed the establishment of the International Criminal Court and is responsible for the Legally correct maintenance of the ICC-institute in its role as International Court of Law; in operations thanks to the Statute of Rome.

8. Ukraine President Petro Poroshenko.
He took office as President for Ukraine on 24 May 2015.
He is responsible for the security of passenger planes flying above Ukraine and for the safety of plane-passengers above Ukraine-territory.
9. Individuals on Ukraine-territory who shot down the MH17-plane on 17 June 2014.

I do want all these persons to be put on trial during an MH17-courtcase.

UNSG Antonio Guterres

I need you to do a part of my job ... for me... now I don't have physical access to the Ministry of Common Affairs NL. You know 'that I will not start a civil war over my labour contract Interim Prime Minister for Holland. One day I will have this labour contract and I will call for Elections for the first Elected Prime Minister for Holland'.

In the mean time... I need you to complete a part of my duties....

ICC-president Judge Silvia Fernández de Gurmendi and ICC-prosecutor Fatou Bensouda must be removed from their ICC-labour contract and be replaced with a new sound working ICC-president and ICC-head prosecutor. Please, make sure that ICC is being 'cleanup and starts to work like a fair court of law is suppose to do'.

MH17-people

When you communicate with the people in Ukraine, explain to them the new Constitution Republic NL. This will bring calmness for their lives and will be a source of inspiration for Problem-solving solutions for non-violent Conflict-ending.

I know from experiences 'that the truth will come to the surface when people feel valued for their positive intelligence'.

And... You already know this...

'What ever happens, I will not have my ICC-lawcase against NL being misused as a cover for murder on Dutch nationals or other People on Earth. I will not have my Social Intelligence being misused for crime'.

Its time to put the MH17-file on a shorter Timeline.

I advice you to accept a Settlement & Payment for the Damage caused by Dutch leaders: 1 million euro per MH17-passenger.

The problem is that Ukraine wants more war: either to become a member of the EU, or to become a member of Russia. War will overshadow the MH17-truth for decades to come... and suspects / perpetrators will die ... Mind my words: 'Nobody will be put on MH17-trail... due to all the NL- ICC- EU - Ukraine - Russia manipulations'.

Its wiser to claim a Settlement & Payment for Damage to be payed by all guilty parties.
