The fact that the Police is set free by the Prime ministers / Ministers in 2006 – 2007/Members of parliament / Monarchy / Dutch supremecourt to torture me, is one of the main reasons for the ICC-lawcase against NL.

Over the past years, the NL-police has in co-work with ICC-personnel spread torture – murder – war over Earth. This lobby has also caused the MH17 -plane crash above warzone Ukraine for fun. And is now falsifying the MH17 legal facts to keep the NL-rulers responsible for the plane to fly over Ukraine – unpunished. ICC assists NL-rulers with these falsifications of legal facts.

For this reason I started an ICC-lawcase against all Members of parliament – Members of the Royal family, Lobbyists and Media-makers in 2015. I also started an ICC-lawcase against former Head of Police Gerard Bouman.

According to the Torture-treaty and all articles torture in all Humanright-treaties, its forbidden to assist a criminal with torture and murder.

The United-Nations – under command of BanKimoon – has always assisted ICC-prosecutors, – judges and administrative personnel with torture and murder on victims who start an ICC-lawcase against their own national corrupt courtsystem and their political leaders, as my file proves.

I am entitled to the labourcontract Interim Prime Minister of the Netherlands, but I don't want to start a civil war for it. Both, ICC and the NL-warcriminals do want me to start a war...and manipulate me to weaken my personal judicial position... so they will remain 'free warcriminals'.

Holland will grow into more mental and physical violence coming year, now I prove that ICC – NL Prime minister / Ministers / Parliamentarians / Members of the Royal family / DutchSafetyboard are the first responsible for the MH17 KLM – Malaysia passengers plane to be shot down above Ukraine territory in war.

When ICC – NL – Monarchy – Dutchsafetyboard would never have lied about the fact that a Dutch woman – me – has been forced to start an ICC-lawcase against NL in order to stay alive.... the MH17 plane would not have flown over Ukraine. People would have learned to protect themselves against the extremely evil ICC-lobby... and would have been able to take better care of their private security. The people would have forced KLM SchipholAirport not to fly over warzone anymore. When ICC would not lie about everything all those wars in the Middle-east would not have broken out or would not have been so painful.

All InternationalCriminalCourt personnel ignores the UN-treaty – Torture-treaty and Humanright treaties when they receipt files for lawcases against corrupt national courts of law and their members of parliament. Nato-members. And members of the Royal family. With the aim to select targets (lawless persons who can only turn to ICC in order to demand their fundamental constitutional and humanrights back) for torture – murder on request of national judiciary systems – barassociations – parliaments / prime ministers / ministers – royal – lobbyists.

You – newly elected UN-SG AntonioGuterres – has the legal obligation to stop the warcrimes which are being conducted by ICC-personnel.

The best way out for you is to give a speech, in which you explain to Earth everything that goes wrong inside ICC. And you need to close this FAKE-court temporarily.

When ICC-personnel is free to travel the World 'for investigations' more wars will break out. Now ICC the turn to the Phillipines and that region.

I can turn ICC into a fair court-system.

ICC should have demanded in may2007 'that the NL Primeminister – Ministers – Mayor & Aldermen Bloemendaal – Police – Members of the Royal family – Dutch safetyboard members – immediately organize a settlement & a payment for the damage they cause me, so I will have my fundamental constitutional and humanrights back and Holland will prove to be a state of law again'.

ICC failed to do this. Over the past 9 years they have send me letters which prove they do operate like a warcriminal lobby-club, instead of a court of law. For fun-killings.

ICC planes to murder more people via lies about my ICC-lawcase against NL, especially now ICC can no longer hide for the world that they support genocide / terrorism conducted by NL. Terrorists are well aware of this situation; when they can no longer fight in the Middle-east they will move to Europe. ICC-personnel wants a civil war in Europe.

An ICC-trial against NL is only possible after ICC has been cleaned up and all personnel is being replaced by new people who to conduct the UN-treaty – Torture-treat – Humanright treaties while working with the Statute of Rome.

UNSG AntonioGuterres, don't give ICC-personnel the freedom to start more wars. And make good use of my Social Intelligence for Peace.

Phillipine President Rodrigo Duterte,

I disapprove of the way you handle drugscrimers in the Phillipines; you may not kill people without a trial – drugstest.

And, I want you to implement the new Constitution Republic NL – which I can bring into charge within 48 hours by decree in Holland –. And I want you to rebuild the Phillipine state of law... following my guidelines. I have also written new laws for the Judiciary system in NL and the Refugee-problem. I intent to write more new laws for Republic NL.
