**Legal position the Netherlands within UN.
Written by InterimPrimeMinister DesireeStokkel, since 18nov2016.**

**Almost 6 weeks have past since 18nov2016, the day I rightfully claimed the
labourcontract InterimPrimeMinister for TheNetherlands.**

You already have all the official letters en my ICC-lawcase against NL on CD.
They ICC-file is also published on my website <http://www.desireestokkel-nl.net/>
This letter will be published too.

I have not received this labourcontract officially; I now must operate from a hidden world full
of manipulations. What I hate...because it triggers more crime – wars.

And I have the Social Intelligence to minimalize crime - wars, so I want to put my skills into
practice.

I planned to provide you with a legal framework – anchored in the UN Charter – that proves
that NL is Dictatorship.

We can keep work simple:

'The President of the Netherlands Mark Rutte and all 225 other Members of Parliament and King Willem-Alexander refuse to exercise every single article of the UN-Charter', which proves that they are dictators'.

Other powerful persons like Mayor and Alderman in the Municipal or Commissioners working for the King with the Province... also refuse to exercise their legal obligations... and refuse to turn dictatorship NL into a State of Law for All of Us, again.

1. I started an International Criminal Court lawcase against NL on 1 May 2007.
2. ICC-personnel hides this legal fact for the People on Earth on their website, but they have sent me letters which prove that I started this lawcase legally correct.
3. ICC-personnel 'obeys NL Prime Ministers – Members of Parliament – Lobbyists... and assists them with torture -murder on victims who start an ICC-lawcase'. They try to murder me.
4. Queen Beatrix should have informed the People about this ICC-lawcase against NL in May 2007. Which she refused, because she liked the game NL-politicians – criminal Judges with the Supreme Court – corrupt lawyers with the Bar Association and Council for Legal aid – ICC were playing with me. They think it's funny to make a Dutch woman fight for her life without access to court for justice.

Queen Beatrix refused to exercise the NL Constitution for Kingdom The Netherlands.

5. Over the past years I started many ICC-procedures against other dictators in NL, who also refuse to operate legally correct in accordance with the NL Constitution – UN charter – Human right treaties, in my life and the lives of others. Letters on my website
6. I started an ICC-lawcase against King Willem-Alexander on 2 June 2014, for the fact that he proves that he wants all 225 members of Parliament to work like dictators... who ignore all legal obligations ... for the People.
7. I could have claimed the labour contract Interim Prime Minister on 2 June 2014. I didn't because I wanted to write a new Constitution for Republic NL.
8. I have written more laws for Republic NL, so the State of Law in NL can be restored. All ambassadors are informed about this situation. I need the official labour contract Interim Prime Minister in order to stop the war-making exercised by NL-rulers and ICC-personnel.
9. When ICC and Rulers in NL would have taken their responsibility for a life anchored in the NL Constitution – UN charter – Human right treaties... the passenger plane MH17 would most likely not have flown over Ukraine-warzone. The People would have been informed about the lack of national security in Holland and would have been able to start to defend themselves against the lies of powerful persons and organisations. The People would have been able to make the Parliament change plane-routes and make planes flight far away from warzone. Other nations had already changed their flight routes and did not fly over warzone Ukraine anymore.

Above analyzed warzone TheNetherlands is not new to you; the fact that I step forwards to end this madness... is new.

I don't want more bloodshed in NL or internationally, caused by NL-rulers and the 100% percent corrupt InternationalCriminalCourt-personnel.

Many individuals are being tormented to death IN NL ... and their bodies are written away in the Statistics.

Many Dutch are not smart enough to put the hel in legal frameworks, like I do.

My claim starts within the UN for Myself – InterimPrimeMinister for NL – article 6 and Chapter VII

1. I want the UN General Assembly and the UN SecurityCouncil to recognize me officially as the InterimPrimeMinister for The Netherlands since 18november2016.
2. I want all communications produced by the United Nations to be handled by me – DésiréeElisabethStokkel, InterimPrimeMinister for NL – from 1january2017 on. From this date I decide whether NL is involved in projects – resolutions or not.
3. I want the UN to recognize my extremely difficult position in the NL- bureaucracy: I don't have acces to trustworthy information produced by the NL-parliament – Ministries – Lobby.

Even when I would have acces, the information would not be trustworthy... now NL-rulers have decide that I must be killed.

They want to stay in charge – despite the fact that the whole World can see that they are dictators and that they dictate ICC; and that ICC-personnel obyes the NL-dictators.

I don't have money. But, I can work on a laptop.

4. I want the International Criminal to be closed temporarily, now ICC-personnel tortures – kills victims who start ICC-lawcases. Now ICC wants terrorism-attacks in EU. And ICC manipulates MH17 flightcrash above Ukraine legal facts, now I prove that ICC-personnel is a hugh terrorism-risk for Earth.

All suspects and criminals on trail with ICC must be brought baqck to hteir Homeland where they will be put on trail for Crimes against Humanity and Warcrimes.

Justice on Earth will change for the better when the UN has established the new UN Commission Arbitration-court-systems to the Convention Arbitration for Problem-solving Justice.

The treaty I have sent to you UNSG Antonio Guterres and all Embassadors.

The UN does not have to expel The Netherlands from the UN, now I prove that it is possible to realize a Regime-change without public violence. NO bomb-attacks of civil war is needed.

I have created a Regime-change in NL by writing smart legally correct founded letters... and send these letters to the UNSG and Embassadors.

The fact that President Mark Rutte and the Commandors of the NL Ministry of Defence ignore my letters, proves that they want bloodshed. The Royal family want bloodshed.
