The Full file of the ICCLawcaseNL is already available with UNSG guterres, against whom I started an ICCLawcase too.... For participating in warcrimes in the Kingdom the Netherlands. All persons against whom I started an ICCLawcaseNL refuse to conduct the Constitution – UNCharter – Torture-treaty – Humanrighttreaties.

Former Defence-Minister Jeanine Hennis-Plasschaert is responsible for the death of NL-soldiers in Mali; she still has to be put on trial for it. This NL-courtcase against Jeanine Hennis-Plasschaert is a redundant act, now there is an ICCLawcase against her.

The Commandors of the NL-Ministry of Defence have started a Civilwar in the Kingdom the Netherlands by training former NL-Defence-Minister Jeanine Hennis-Plasschaert into Captain at Sea for the Royal Navy. The NL-Ministry of Defence has turned against the people of NL and its own NL-Defence-personnel.

All person against whom I started an ICCLawcaseNL, participate in this war. All Boardmembers of organisations I contacted over the past year, with the aim to stop DictatorshipNL and activate RepublicNL..... are too indifferent towards their personal safety & national security = they don't care if NL is a Dictatorship.

What next?

Well, I have to be clear: terrorists are terrorists, whether they own a Dutch passport or not.

For all UN-memberstates is forbidden according the UNCharter – Torture treaty – HR treaties – UN resolutions on terrorism to do Business with the persons against whom I started an ICCLawcase and who prove to be terrorists who turn against their own NL-people.

As InterimPrimeMinister for The Netherlands, I determine that the NL-terrorists against whom I started an ICCLawcaseNL must be arrested; they can no longer travel around the World as if they are persons who can be brought to ICCtrial and who will learn a lesson in Justice thanks to a stay in ICCprison.
